Protective gloves

- The glove material has to be impermeable and resistant to the product/ the substance/ the preparation. Selection of the glove material on consideration of the penetration times, rates of diffusion and the degradation*
- **Material of gloves**
*Butyl rubber, BR
The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.*
 - **Penetration time of glove material**
Butyl rubber gloves with a thickness of 0.4 mm are resistant to:
 - Acetone: 480 min*
 - Butyl acetate: 60 min*
 - Ethyl acetate: 170 min*
 - Xylene: 42 min**The exact break through time has to be found out by the manufacturer of the protective gloves and has to be observed.*
